Age Relaxation and Additional Weightage of Marks applicable for the eligible applicants who are employees of the OSH&FW Society(NHM).

The candidate has to exhibit requisite documents / experience certificates which shall clearly establish his/her eligibility as per conditions as above, without which his/her candidature shall be rejected. The experience certificate of the Employer/s must clearly specify the period of incumbency, name of the post and nature of responsibility.

In case the marks obtained are in the form of CGPA, OGPA, DGPA, GPA, CPI etc., a certificate for conversion as applicable to percentage of marks shall be submitted at the time of submission of application form. Entomologist, NVBDCP:-

Qualification:- The candidate must have passed Post Graduate Degree in Zoology or any other branch of Bio-Science or Life Science from a recognized University / Institution with minimum 55% marks. For Life Science candidates, Zoology should be one of the subject at Degree level.

Experience- The candidate must have 02 years of post-qualification experience in Vector Borne Disease Control Programme under Public Health System.

Upper Age Limit-Upto 40 Years

Selection Procedure: - Application Invitation (Interview -100 marks)

A list of eligible applicants, fulfilling the eligibility criteria shall be prepared on the basis of percentage of marks secured in final examination of the each required qualification in order of merit.

From amongst the said list of eligible applicants, 5 times of the number of vacancies from the top of merit list of each qualifications as mentioned below shall be called for appearing Interview.
